

Special Board Meeting

The Full Board met on Monday, March 19, 2018 @ 4:00 p.m. at 316 S. Brad Street, Grantsburg, Wisconsin.

The Special Board Meeting was called to order at 4:00 p.m. by Village President, Larry Ebersold.

Village President, Ebersold wanted to look at the 3 items on the agenda other than review of the codes first. The agenda order would be changed. The first order of business was to review Amanda Meyer's request to place a tiny house on Lot #6 on Linden Street North. The house is 375 square feet and 13' wide by 20' long. She also noted that she will skirt it and put a small deck on the front as well. The property is zoned R4. She intends to place a cement slab or patio slabs under the house. It is on a trailer. The property has water and sewer adjacent to the property, so it would need to have that service. There is a conditional use that she would have to apply for under the R4 zoning. There is nothing that says she can't place the house under this zoning as long as it is conditional.

Village Trustee, Barton moved, seconded by Village Trustee, Coy to let Amanda Meyer know that the village board does not object placement of Amanda Meyer's tiny house on Lot #6 Linden Street North on a slab. She would need to apply for the Building Permit and Conditional Use Permit for placement there once approved by the Plan Commission and Village Board upon submittal.

Rebekah Stavne – Community Education Coordinator of Grantsburg High School submitted a request for Pianos on Parade. The program would be implemented through Grantsburg Community Education; Grantsburg High School Art Class; three local donors along with Keys 4/4 Kids. Grant Dawson is the event organizer who has close ties to Grantsburg. There will be playing of the piano by anyone interested in doing so as well as local pianists. They would like to place a piano that is decorated with artwork at the closest pavilion at Memory Lake Park to the downtown area. The piano is recyclable and would be placed there the 1st Saturday of Big Gust Days in June 2018 and be placed there for 30 days. The project cost is \$1,500 which will be paid for by 3 donors at \$500 each. Once display of the piano is done, the piano will be moved from the pavilion. The hope is that vandalism doesn't occur. Ms. Stavne understands that is a possibility.

Village Trustee, Muehlberg moved, seconded by Village Trustee, Barton to inform Rebekah Stavne that the board gives her permission to place the piano in a portion of the pavilion closest to downtown on Memory Lake for a period of 30 days starting on Big Gust Days and placed there for 30 days. At such time, the piano will be removed.

The board continued reviewing the "Guidelines for Draft Review" of the draft ordinances with General Code. This is the second meeting for review of those guidelines for revisions that are due to General Code by May 4, 2018. The board started off reviewing Chapter 387 Nuisances. The board looked at 2 samples from the Village of Kimberly, WI and the Town of Trenton, WI for possible inclusion of either under that chapter. Village Trustee, Barton liked the Town of Trenton sample as it covered more concise detail in her opinion. Village Clerk, Bjorklund noted that there should be change from Town Finance Director to Village Treasurer within the scope of the ordinance. All other town references should be changed to village.

Village Trustee, Peer moved, seconded by Village Trustee, Stone to use the Town of Trenton, WI sample for Chapter 387 Nuisances for the new Village of Grantsburg Code.
