Recreation Committee Meeting

The Recreation Committee met on Monday, December 3, 2019 at 5:00 p.m. at 316 S. Brad Street, Grantsburg, WI.

Committee Chairman Muehlberg called the Recreation Committee Meeting to order at 5:00 p.m.

The Pledge of Allegiance was recited.

Discussion/Action: Community Center a) Rental Agreement with Grantsburg School District. The committee reviewed the agreement approved by the Grantsburg School Board. The committee had requested the School Board consider changing the term of the rental contract to coincide with the gymnastic schedule. The School Board chose to leave the term from January to December but agreed to the increase in fees. **Motion by Trustee Roberts, second by Trustee Barton to recommend the Village Board approve the Community Center Rental Agreement with Grantsburg School District for the gymnastics program with the rental at \$7.00 per hour, storage room rental at \$100 per month and a term of January 1, 2020 to August 31, 2020 with a new contract to be negotiated in May/June. Motion carried.** **b) Library Use for Wee Play Program.** The committee reviewed the letter received from the Library requesting use of the Community Center. The committee has heard favorable comments about the program. **Motion by Trustee Barton, second by Trustee Muehlberg to approve the Library use of the Community Center on Friday mornings 10:00 a.m. to 11:30 a.m. from January 3, 2020 to February 28, 2020 for their Wee Play Program. Motion carried.** **c) Advertising.** The committee discussed creating a flyer link to the Village's Facebook page, having an article in the Village newsletter and sending Community Center rental information to area organizations.

Discussion/Action: Tanker from Blueberry Special Train. The committee was generally in favor of finding a spot for the tanker to be displayed if another group would be in charge of cleanup, renovation and development of the display at no cost to the Village. Trustee Muehlberg will reach out to members of the Grantsburg Revitalization Organization (GRO) and see if they are interested.

Discussion/Action: Skating Rink Concession Schedule, Signage. The committee reviewed a letter and list of non-profit organizations drafted by Deputy C/T Longhenry regarding the skating rink concession usage. An adult will have to be present with any group that is running the concession stand. All items will be provided by the group scheduled and all proceeds will be kept by the non-profit group. The letter will be sent to area non-profit organizations so they can call the Village Office to be scheduled. Skating rink flyers will be distributed to the schools for inclusion in the Friday folders for grades up to 6th grade. The Committee would like the Village Board to consider having an open house and ribbon cutting at the skating rink on Saturday, January 11, 2020 at 10 a.m.

Discussion/Action: Adjournment. Motion by Trustee Roberts, second by Trustee Barton to adjourn the meeting at 5:50.
